Current and Forthcoming Reviews

Working with Scarborough Hospital

We have now commenced work with Scarborough Hospital to provide informal early advice on their obstetrics and gynaecology service. Our panel is established with thanks to those Assembly members who came forward to assist. The panel has held its first discussion and has asked for further supporting information from the Trust. Key lines of enquiry have been fed back to the Trust and we hope to be able to arrange a discussion with the Trust and CCG clinical and commissioning leads in late March.

Due to the COVID pressures the work with Scarborough hospital on their emergency and acute medicine model has been delayed until March. The panel is established and ready to support when we are able to commence this work.

Working with Cheshire East on a model of care

We now have a fully established panel for the work with Cheshire East on their model of care. The panel has received the supporting information and held its initial discussions. Key lines of enquiry have been fed back to the Cheshire East system and we are now looking to organise a date to hold a discussion with their commissioning and clinical leaders in mid to late March.

Bassetlaw mental health service review

Our report has now been published on our website and can be viewed via this link.

Other Potential Reviews

Our further work with **Wakefield CCG** on the completed draft pre-consultation business case for the **Pontefract Midwifery Led Unit**, and the work with Bradford CCG on Shipley hospital, remains on hold. Discussions have commenced with the system supporting **Southport and Ormskirk** on working with them again on their developing discussions on acute hospital services. We may also be working further with Humber Coast and Vale as their proposals develop.
