Current and Forthcoming Reviews

Working with Southport and Ormskirk

We have been contacted by the Shaping Care Together Programme to ask if we will work with them again to provide informal advice on their developing programme across acute and planned services. We previously worked with the programme in 2018.

Currently we are expecting to advise on their options development end July/ early September and need clinical panel members across urgent and emergency care, children's services, maternity services, planned care, frailty services and the broader out of hospital model. **If you would like to express your interest in participating in this panel please get in touch and we will keep in touch with you as the details and timeline develop.**

Working with Scarborough Hospital

Our draft report providing informal early advice on the Scarborough Hospital obstetrics and gynaecology service is now complete following a very helpful discussion with Trust clinical leads in March. The draft report is now with the Trust for comment.

Working with Cheshire East

Our report for Cheshire East is now complete and is with the commissioning leads for comment. It was not possible to arrange a follow up clinical conversation with the clinical leads and the advice therefore only contains a broad overview to assist with their next steps in the development of their model of care.

Both of these reports will be ratified by the Senate Council at their meeting on May 17th. My thanks to the panels for their work on these reviews

We remain in discussion with:

- **Wakefield CCG** on the completed draft pre-consultation business case for the **Pontefract Midwifery Led Unit**,
- **Bradford CCG** on **ShIPLEY Hospital**.
