	The areas for potential Senate support would be for large scale change, unwarranted variation and the sharing of good practice	
	A discussion followed the presentation which is summarised below.	
	The mapping of pathways for ADHD and autism services for children will be carried out as one piece of work, however for adults, the services will form two distinct pieces of work.	
	The system wide approach to dyslexia in children is picked up through educational psychology. The method is different for adults which may result in gaps. As providers have different models, it was suggested that community connectors could be used to link people into services.	
	There will be joint working with acute provider collaboratives as there is a large overlap with the physical health sector.	
	The Senate will be undertaking a review of autism and ADHD in West Yorkshire and offered to share any useful outputs from this with South Yorkshire colleagues.

40/22	Update from Senate Chair National Meeting	
	This was provided as an additional agenda item by the Chair.	
	The meeting agenda included the following:	
	An update on NHSE and Senates from Vaughan Lewis NHSE are reducing their headcount by approximately 30% while simultaneously absorbing NHS Digital and HEE staff. The expectation is that oversight will be at a more regional level than national, however strategies will be set nationally. There are no planned changes to Senates.	
	There is a drive to reduce the use of management consultants which could lead to an increase in work for Senates. V Lewis asked if there might be a need for Senates to review how virtual wards function as different methodologies are used to deliver them.

	A presentation around service change and the Health and Care Act 2022 The key points were that the act requires the ICSs to notify the Secretary of State of any major changes and then the Secretary of State has the right to call in such major changes for his personal review. Also included is a catalyst power which enables the Secretary of State to require ICSs to consider the reorganisation of services in a particular patch. This does affect the Senate role in providing assurance and advice. Net Zero NHS Sustainability in quality improvement is part of the work of Net Zero NHS. They have a new equation – the value of a change is considered as the outcome for patients and populations but divided by social, financial and environmental costs – the new triple bottom line.
